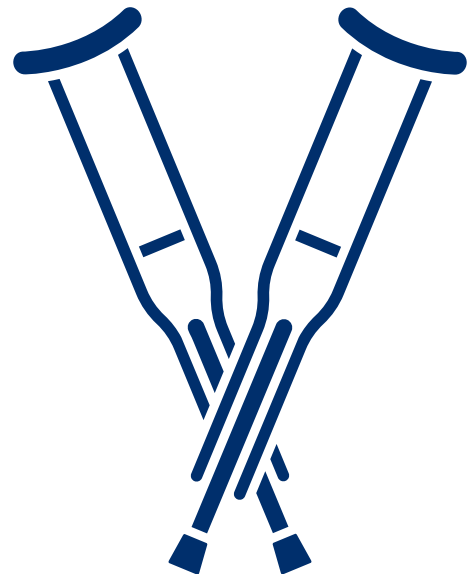

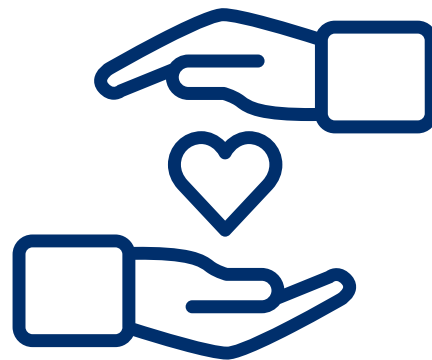

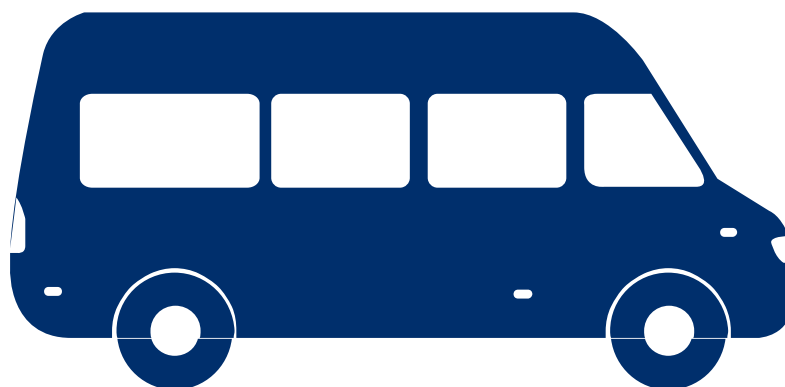

For patients enrolled in managed care organizations, the patient needs to verify with their managed care organization which practitioners, providers or certified suppliers are in the managed care organization's network. The hospital assists in the discharge planning process but must not specify or otherwise limit the qualified providers or suppliers that are available to the patient. The patient or the patient's representative has the freedom to choose among participating Medicare providers and suppliers of post-discharge services and the hospital must, when possible, respect the patient's or the patient's representative's goals of care and treatment preferences, as well as other preferences they express.
